
### **US Indo-Pacific Strategy after One Year: Perspectives** from Allies, Partners, and across the Indo-Pacific


The East-West Center in Washington, in coordination with the Yokosuka Council on Asia-Pacific Studies (YCAPS),

July 11 to 13, 2024. Part of the Young Trilateral Leaders Initiative, The Summit brought together emerging leaders from the United States, the Republic of Korea, and Japan, with additional representatives from Southeast Asia and the Pacific Islands. The summit was held in Busan, Korea and addressed issues such as environmental resiliency, economic innovation, and national security concerns through simulations of Camp David and a competitive pitch competition.
