This report deals with governmental, corporate, and international policies and decision-making toward pandemic response aboard cruise ships and at ports. Focusing primarily on two case studies that

took place in February 2020—the Diamond Princess and the MS Westerdam—this briefing document highlights relevant policies that were and were not employed, assesses the effectiveness of these policies, and considerations for policymaking in the future.
